Bridal Contract

Securing Appointment

All dates are on a first come- first serve basis based upon salon and clientele needs. If we can accommodate you on the date requested, your appointment date(s) and service(s) will be secured after the retainer fee is processed. At your trial we will discuss the contract to be signed and a deposit will be collected. The requested date will be reserved upon initial discussion and trial appointment, however will not be guaranteed without receiving a signed contract and deposit. Up to the discretion of Hairbybrennahhh, the contract must be signed within reasonable notice on an agreed upon due date. Authorization indicates the owner's signature acknowledging the due date.

On Location Bridal

Hairbybrennahhh will accommodate any on location services by traveling to you on the day of the wedding. Any hair trials you wish to have are to be services at The Network Salon. The flat rate for an additional travel fee is \$40 per stylist for every additional 15 miles driven past 409 Canal Street, Plantsville CT. The travel fee for locations in New York or Massachusetts will be determined after time of consult. If artists deem a hotel room may be needed to ensure correct start time the bride agrees to pay for lodging of 1 room for the stylist(s)

On Location Space Requirements: a designated space to set up on location is required. The bridal party is responsible for arranging or cleaning an area to set up before stylist arrive. We travel with a ring light and an extension cord. If the space is not ready to begin working on at time of arrival, a \$20 late fee for every 10 minutes will be charged (see Late Arrivals/Tardiness section below). The work area will require a suitable chair and outlet available per stylist on a no-walk area so that traffic does not interfere with the services. If the services cannot be performed due to insufficient work area, the contracted services may be reduced at stylists' discretion and you are still responsible for total payment. Stylists are not liable for injuries or any damages that arise on location.

Our stylists also offer "on location touch ups" to stay for the duration or a portion of your wedding changes required throughout the wedding. An hourly fee will be assessed if this service is requested per stylist.

Hair Color Incentive While Under Contract

A super big thank you for scheduling your wedding with my company, my wedding gift to you, the bride is a beauty night out of your choosing whether it be for your bachelorette, bridal shower or rehearsal dinner, come in to the salon and experience a Lux Blowout service valued at \$110 which includes a clear shine treatment, a deep conditioning treatment with a relaxing scalp massage followed by a flawless finishing style touched up with the hot iron.

As soon as this contract is signed and retainer and/or deposit is received, your bridal party will receive 20% off all hair color services at The Network with Brenna up until the date of the wedding. We want you to look your best and are happy to do your color to prepare you for the big day! This cannot be combined with other offers and only applies to those who are in the bridal party. Discount is nontransferable.

Payment

The remaining balance after the deposit is paid (deposit is remaining balance of bridal hair \$140) is due no later than the morning of the wedding service. Payment plans are available upon request with approval. Payment plans available in either weekly, biweekly, monthly, or customizable installments. However, the full payment must be paid off by the morning of before the services are begun. Credit cards will be automatically charged on dates and amount agreed upon within payment plan or the morning of the wedding. Cash or check must be received in hand before any services begin the morning of. We accept cash, check and all major credit card companies.

* Credit card is stored in our super secure SquareSpace server. If you choose to pay by credit card a convenience fee of 5% will be added on to final payment. We appreciate your understanding.

No charges will be made to your credit card until services are preformed or agreed upon payment plan dates. All cancellation, late fees, and contract policies stated within this document will be upheld and in the event any of them are utilized, broken or changed, the charge will be placed on your card with notification.

Contract/Appointment Changes

All agreements will be made in writing. Wedding date, time, services, time of arrival, number of guests, or any other changes to the contract must be made via email, mailed written letter, or in person. Attempts to make changes via phone call including a voice mail, all social media platforms, text messaging, will be denied and redirected toward any of the approved options listed above. Changes will be accepted UP TILL 2 weeks in advanced to date of service otherwise fees may apply. Please note that changes are at discretion of owner in accordance to accommodating each guest appropriately with the time allotted the day of the event. Any changes made

within less than two weeks will be subject to fees. If decreasing the services needed, the deposit will not be returned. If additional services are required with less than two weeks advanced notice, one-half of the total amount will be added on to the initial service fee, totaling that service at 150% of the initial listed price. No changes are allowed to be made to the contract by anyone else but the bride, unless otherwise authorized to do so. If anyone unauthorized attempts to submit a change to contract, the request will be denied.

Cancellation/No Show Policy

Overall cancellations must be made no later than two weeks in advanced to date of wedding. No additional charges will be made. If cancellation takes place less than two weeks in advanced an additional 50% of total cost will be charged in addition to the already collected deposit. Deposit and retainer fee are both, as stated, non-refundable. If you are a no-show the day of the services that are contracted, or cancel less than 48 hours in advanced, 150% of the total payment cost will be charged.

* Cancellations due to emergencies are considered on a case by case basis per the salon owner's discretion.

Late Arrivals/Tardiness

Because of scheduling and service conflicts, there will be a late charge fee. For every 10 minutes the bridal party is late past the contracted time, a \$20.00 late fee will be assessed. If the bridal party is more than an hour late, this will be considered a "No show" and follow the policies listed. After an hour of tardiness, you will be charged the full amount of the total payment contracted. If unexpected tardiness affects the time allotted for certain services, the services may be reduced or altered for the new allowed time. However, you are still liable for the total payment. We apologize for any inconvenience but we must follow this policy to ensure you receive quality service in the time allotted for and out of respect for our stylists and other guests. We thank you for your understanding.

Special Requests/Miscellaneous Information

- Bring any accessories/flowers for hair the day of.
- Wear a zipper or button down shirt. If a pull over is worn, we cannot guarantee the service for hair will remain the same after getting dressed.
- Arrive with clean, dry hair. Wet hair will be charged as a *add on blowout
- Clip ins can be styled with the hair at stylist's discretion. Only human hair extensions will be styled, no exceptions whatsoever. Fee will be added at stylist's discretion.

*Blow dry charge added if this request is not met as it affects scheduling of contracted services. Services may be reduced, but still liable for total payment unless contracted in advanced of event.

-If anyone in the party is not receiving a trial, they must email a picture of themselves with their natural hair down and a picture of desired hair style/updo so that the stylist can ensure we are equipped with the proper tools to complete the look and that it is achievable.

Deposit

All reservations for wedding parties are contracted with a deposit that is a total of \$140. Deposits are to be paid the day the contract is signed and only then will the date be reserved (see Securing Appointments). Authorization indicates the owner's agreed upon deposit amount; the due date can be referenced above. All deposits are non-refundable.

** If your CC is stored in Square already you do not need to fill this out. Please just sign and acknowledge that it has been read through. If you are interested in a payment plan or bridesmaids are interested, then the bride will be responsible for setting that up.
